 - -I-card in college campus is compulsory.

The anti-ragging squad member works regularly and is meant for taking care of issues regarding ragging.

- The contact details of the committee members are displayed on the notice board and at prominent places in the institute.
- The provisions for action against ragging as stated in the Maharashtra Prohibition of Ragging Act 1999 are permanently displayed on a notice board and included in the institute brochure.
- The students and their parents are made aware that the student will not indulge in any form of ragging and has clearly understood the consequences of ragging.
- To prevent and eliminate ragging in all its forms, online undertaking is filled by each student and confirmed by his/her parents or guardians on the web portal www.antiragging.in, provided by UGC. CCTV cameras are installed at various strategic positions in the institute and hostels to ensure that no such incidents will occur.
- Surprise visit to various places in the campus is arranged by the Anti-ragging squad to ensure ragging free environment.



Rules & Regulations for Prevention and Prohibition of Rugging

The At India Council For Technical Education (AICTE), New Dath vide its Notification no. 37-9/Legal/AICTE/2039 dated 25-03-2009 has taken a very serious view of rapping incidences in educational institutions and on Directions of the Hun'ble Supreme Court of India vide its Onder dated 15.5-2007 has ordered attict implementation of following rules & regulations to: Prevention and prohibition of Rapping in technical institutions:

Actions to be taken against students for indolging and alterning in Ragging in technical institutions. Dailyersities including Deemed to be University impairing Sachnical educations.

- 1. The punishment to be mered out to the pursons indulged in tagging has to be exemplary and just if labily hash to set as a decrease against recurrence of such incidents. The students who are listed to be indulged in regging should be debursed from taking admission in any technical institution in India.
- Every single incident of maging a First Information Report (FIR) must be filled without exception by be institutional authorities with the local police authorities.
- The winding upon me nature and growty of the offices as established by the Anti-Ragging Committee of the institution, the possible punishments for those found godly of ragging of the institution level shall be any one or any combination of the following. () Cancel at an off-acmission (i) Suspension from situraling classes (ii) Withholding/withdrawing satisfarship/fellows(t) and other neneflits (iv) Debarring from apparent in any test-examination or other evaluation pracess (v) Withholding results (vi) Debarring from representing the institution in any regional, nanocal or international meet, to manneat, youth festival, etc. (vii) Suspension/expulsion from the hestel (viii) Rustication from the institution for period tanging from 10 4 semesters (iv) Expulsion from the institution and constrained debarring from admission in any other lists ation. (v) From of Rupees 25,006 (vi) Collective punishment, when the persons committing or aborring the crime of regging are not identified, the institution shall resort to unfloctive punishment as a detector to ensure community pressure on the personal reggers.
- 6. The institutional authority shall into see the incidents in ragging occurred in their premises along with across taken to the Council immediately other occurrence of such incident and inform the status of the case from time to time.
- 8. Courts should make an effort to ensure that cases invisionly ragging are taken up on priority basis to send the correct message that ragging is not unity to be disapprayed but also to be dealt with stormess.
